1. General comments

This mission report was prepared within the EU Twinning Project "Support to the State Statistical Committee and the State Tax Service under the Ministry of Economy to strengthen collection, harmonization, analysis, publishing and dissemination of business statistics". It was the first mission to be devoted to redesigning the structural business statistics (SBS) within Component 2, Result 4 within Activity 4.1 of the project.

The purposes of the mission were:

• Result 4: Business Statistics (BS) in Azerbaijan redesigned.

The consultant would like to express his/her thanks to all officials and individuals met for the kind support and valuable information which he/she received during the stay in Azerbaijan (or Remote Sessions and which highly facilitated the work of the consultant.

This views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of EU, SSC, STS, SME-Agency, Statistics Finland, Statistics Lithuania, Statistics Netherlands, Statistics Denmark and HAUS.

2. Status at the beginning of the mission

Activity 4.1 was carried out on four Remote Sessions (RS - WebEx meetings). The last RS presented the observations made during the previous sessions and translated into proposals for improvement of the process, whereas the RS's before focused on analysing the situation in STS and SSC and presenting best practices out of MS.

- Currently, the SBS is not centralized in the SSC and the indicators are prepared by the following structural units of the Committee:
 - Department of National Accounts and Macroeconomic Indicators Statistics;
 - Coordination of statistical work and strategic planning department;
 - Department of Industry and Construction Statistics;
 - Department of Trade Statistics;
 - Service Statistics Department;
 - Department of Labor Statistics.

SBS is covered through observations on SBS, activities of market producers - statistical units classified by sections B-N and P-S of the NACE rev.2 classification. Most of the indicators described in Regulation (EC) No. 295/2008 of the European Parliament and the Council of 11 March 2008 are being prepared. Indicators which are not typical for the country's economy such as the activity of private pension funds, special indicators that are typical for the EU, as well as insurance, banking sector, financial market instruments, etc. are exceptions. Mr. Suleymanov mentioned that the data sources of SBS are:

- Statistical surveys of legal entities and their local units;
- statistical examinations of individuals engaged in entrepreneurial activity without establishing a legal entity;
- Business Register information;
- State Tax Service;
- Central bank.

Mr. Suleymanov emphasized that SBS indicators are formed based on survey data of non-financial institutions, credit and insurance organizations, non-financial enterprises-legal persons and their units.

Mr. Suleymanov continued with the SBS methodology and classification. The methodological basis for the development and dissemination of SBS is as follows:

- Principles and concepts reflected in the relevant EU regulations;
- Methodical recommendations and instructions of international organizations in the field of SBS.

National versions of NACE rev.2 and CPA-2008 classifications are used to develop SBS. The quality and comparability of the data is ensured using a special software product - "Quality Control Tables", which ensures the detection of errors and inconsistencies in the data collected from respondents. Compared to standard software tools, this product is more flexible and better adapted to the structure of existing databases.

3. Status of mission results

- During the mission, the Short Term Experts (STE) presented the current SBS EU regulations, which have just recently been altered due to the new legislation of the European Business Statistics.
- The presentation was also based on the methodological guideline for the SBS production system, which was only at a draft state, at the time of the mission.
- The STEs also presented the experience and best practices of the production systems in two EU member states Lithuania and Denmark. To give a benchmark for a possible to be situation. Even if there were differences between the systems, there were far more similarities.
- Based on input from the STEs, the BC presented the availability of data needed to comply with the EBS (country level and region statistics). An analysis was facilitated to identify the gaps between the current state and the requirements.
- During the mission there were vivid discussions on the use of administrative data (AD). The SSC stated that design of SBS is one of the most important expected result of this project. Main potential AD source is the STS. Currently, the SSC does not use any STS data in enterprise statistics excluding business register. There is a clear understanding of the advantage of using AD based on the presentations made by the STE. That's why the SSC will take specific steps in order to apply same principles within the project.
- At the end of the mission, the participants agreed on the Mission report

4. Sustainability of the achievements

All parties agreed on the Activity analysis. Should the need arise, adjustments can be made later through the rolling work plan.

The project have a strong intention, to start using administrative data in the production of SBS statistics, and will work on a sustainable production system throughout the component.

5. Recommendations for the future (short and long term)

- The STE recommends that the SSC moves towards a common database, where data elements for business related data is stored in a centralised depository where all departments share their data at micro level.
- The STEs recommend, that the SSC reviews the possible new AD that can be found for business based on the tax statements from the STS

- The STEs recommend that the SSC and STS reach an agreement for exchanging pilot data for analytical purposes in the very short term, and an agreement for more permanent data deliveries in the medium to long term.
- The STEs recommend that the SSC discusses between the business statistics department and the statistical business register if there are problems with identifying the local units that corresponds to a legal unit, and thereby to an enterprise.

6. Identification of needs for additional support

• The BC will work further on these recommendations in collaboration with the STEs on the coming activities of this component.

7. Outstanding issues

• There are no outstanding issues in light of the objectives of this particular activity.
