1. General comments

This mission report was prepared within the EU Twinning Project "Support to the State Statistical Committee and the State Tax Service under the Ministry of Economy to strengthen collection, harmonization, analysis, publishing and dissemination of business statistics". It was the first mission to be devoted to Result 5 "The preparation, presentation and dissemination of Annual SME statistics report supported in line with EU/OECD definitions" within Component 2 of the project. Mission included four remote sessions.

The purpose of the mission was:

SME Indicators with a list of indicators expanded in line with EU/OECD definitions

The consultants would like to express theirs thanks to all officials and individuals met for the kind support and valuable information which they received during the Remote Sessions and which highly facilitated the work of the consultant.

This views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, SSC, STS, SME-Agency, Statistics Finland, Statistics Lithuania, Statistics Netherlands, Statistics Denmark and HAUS.

2. Status at the beginning of the mission

BC has confronted increasing demands from the government, the business sector, international organizations and the public at large for timely, reliable and internationally comparable business statistics for monitoring policies on businesses as well as on SMEs.

BC has an annual publication about SMEs "Micro, small and medium entrepreneurships in Azerbaijan". Definition of SMEs in yearbook is based on the decision of the Cabinet of Ministers of the Republic of Azerbaijan dated December 21, 2018, № 556. Definition of SMEs might change during years depending on the decision of the Cabinet of Ministers of the Republic of Azerbaijan. Current definition reflects the European Commission Recommendation (2002/361/EC) concerning the definition of micro, small and medium-sized enterprises but is not fully in line.

Currently BC is publishing over 20 SME indicators but to fulfil increasing user needs, list of indicators needs to be expanded. Indicators are published in a yearbook (pdf) and in excel-sheets on the webpages of State Statistical Committee. Yearbook includes a range of indicators as data tables, at the moment no additional analysis is provided.

3. Status of mission results

Current state of SME indicators was presented by BC and discussed with participants. Challenges of SME indicators were raised. European Commission Recommendation (2002/361/EC) for defining SMEs was introduced. Recommendation takes note on the size of company (number of employees, turnover and/or balance sheet total) but also independency of the company. European Business Statistics (EBS) Regulation (2019/2152) and EBS Implementing Regulation (2020/1197) were introduced based on the indicators and tables where size categorization is required with the exception of Business Demography (BD). BD will be covered in later Activities. User needs, including requirements by EBS, were well recognized and prioritized.

Mission was completed according to plans without any major problems.

4. Sustainability of the achievements

A list of new SME indicators to be pursued in short and middle term was formed during the activity. The list was based on the recognised user needs, EU requirements and potential availability of data. Some of the set targets are more uncertain at this point. The viability of the list will be scrutinised during the following activities. Identified obstacles relate to e.g. lack of suitable data, needed software changes and survey sampling design. The resources for the work on SME indicators are limited so the preliminary targets set at this point need to carefully prioritised in the next steps of the project.

5. Recommendations for the future (short and long term)

Short-term recommendations:

- To work with data providing departments within SSC to investigate the ability to have SME breakdown on already published business statistics indicators.
- Start initial negotiations with State Tax Service and the State Customs Committee to investigate the possibilities of obtaining export and import data either on SME breakdown or on the microlevel (exports and imports for each tax identification number).

Mid-term recommendations:

- Start initial negotiations to investigate whether district courts keep records of the court cases by legal entities (business ID) or if this would be possible in the long run if indicator is necessary to SME Agency.
- Investigate whether it would be possible to maintain two separate SME definitions at the same time: non-stable national definition and stable one. The stable one could be based purely on employment category as required by the EBS Regulation. If the software and sampling design requirements would allow this at reasonable cost, then preparations for production and dissemination of the most relevant indicators based on stable SME definitions should start. This would permit maintaining longer time series and thus monitoring for instance the effectiveness of SME roadmap measures on a longer time span.

Long-term recommendations:

• Consider organising regular meetings between SSC and SME Agency to continue cooperation between agencies on SME indicators. This would enable straight feedback and communication of the most up to date user needs as they might change over time.

6. Identification of needs for additional support

The BC should be able to implement these recommendations, but the project will follow up on progress during the project. Some key components relating to the SME work will be handled in result 2/component 1 of the twinning project: 1) indicators on business demography and 2) determining the independency of a unit (statistical unit enterprise).

BC will investigate in more detail providers of data sources for the potential new indicators. After that RTA and related parties will investigate possibilities to start discussions with the identified Administrative Data supplier organizations.

7. Outstanding issues

There are no specific outstanding issues.


